wishes to file a complaint under 42 U.S.C. 1983 denial of civil and

3. STATEMENT OF CLAIM: 1. Dylan Stephen Jayne, plaintiff, has a social

2. Plaintiff has on file in Scranton Federal Civil Court in the state of Pennsylvania a Complaint No. 3: CV 07-1113 that names Employees of Pike County Correctional Facility in charge of that Facility: Wardens, classification, Programs, and Psychiatry

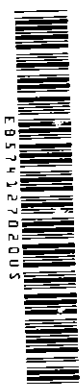
